

**COVID-19 FAMILY ACKNOWLEDGEMENT, WAIVER,
RELEASE, AND INDEMNITY**

St. Theresa Parish Preschool

Existence of Pandemic. We live in the age of the COVID-19 global pandemic. We acknowledge that COVID-19 is highly contagious, that it can be difficult to identify in others, and it poses a risk to those who are exposed to it.

Exposure from Attendance. My child's attendance and involvement in the Preschool is strictly voluntary and may expose him/her and others in my household to COVID-19.

Risks from Exposure. Exposure to COVID-19 may lead to infection with COVID-19. That infection may result in injury, illness, or death, or loss of damage to property, exposure, infection, and their results are referred to in this document as the "Risks".

Acceptance of Risks. I acknowledge and understand the Risks from attending or being involved in the preschool environment. I voluntarily assume those Risks.

Compliance with Health and Safety Plan. I have read the Health and Safety Plan given to me and located on the website. I understand the health and safety protocols and I will comply with the Health and Safety Plan.

Waiver of Insurance and Compensation. I accept that the Parish, the Bishop of Allentown, and the Diocese of Allentown have no obligation to provide any insurance or other financial assistance for me. I will be responsible for the costs, which directly come from my child's attendance at or involvement in preschool activities. I expressly waive any possible claim for compensation for them from the employees of St. Theresa Preschool, the Parish, the Bishop of Allentown, and the Diocese of Allentown.

Release of Liability. I, hereby, waive, discharge, and agree not to sue the Parish, the Bishop of Allentown, and the Diocese of Allentown, and their respective affiliates, members, trustees, directors, officers, employees, volunteers, agents, contractors, representatives, successors, and assigns (collectively, "Released Parties") for any and all claims, costs, liability, and damages which directly come from my attendance or my child's attendance at or involvement in preschool, I make this release on behalf of myself.

Indemnity. I agree and will indemnify, save, and hold harmless each of the Released Parties from any and all litigation expenses, attorneys and experts fees, loss, liability, damage, judgement, and cost which the Released Parties may incur from claims by others arising from my attendance at or involvement in preschool.

Declaration. By signing or electronically accepting this document, I acknowledge that I have read this COVID-19 Family Acknowledgment, Waiver, Release, and Indemnity and fully understand it. I understand that I am giving up substantial rights, including our right to sue. I acknowledge that I am doing so freely and voluntarily. I intend this document to be a complete and unconditional waiver and release of liability. Furthermore, I will comply with all of my obligations, such as answering the daily screening questionnaires accurately, and notifying the preschool of any family exposure to COVID-19.
